The Board is willing to wait until Friday to see if the missing coverages can be added to either of the proposals. If they cannot, Jason is being instructed to talk to them about putting together the best policy we can via splicing together the two policy proposals to get the best coverage we can.

<u>Motion:</u> Betsy moved to tentatively accept Hub's proposal for General Liability and Property and have Jason contact the two insurance companies to fill the coverage gaps. If they cannot get one policy to cover it all by Friday, look into splicing together the RMI Error and Omission portion of the policy with Hub's. If this is not possible then hold an email vote to approve the best plan available and Alan seconded.
