 - 2- Replace analog Thatcher wellhouse meter with a digital one.
 - 3- Replace the side garage door with an actual exit door.
 - 4- Replace E. Church, E. School, and Smith St. steel main lines with larger pvc main lines.
 - 5- New storage tank on Circle T side of river in case of under river line failure and to increase fire coverage capacity.
 - 6- Circle T wellhouse pipe refitting, the addition of a backup power generator, and possibly adding an emergency pressure regulator in lieu of a new tank on Circle T side of the river.
- The 2024 proposed budget was briefly reviewed and the Board agreed to tentatively adopt the proposed budget pending further review.
